penalty notices - randwick.nsw - 'review' of the penalty notice by referring your request directly to the state debt recovery office (sdro). the sdro will consider any request for a review of the penalty notice in accordance with the sdro review guidelines. alternately, the person may elect to have the matter heard in court.
